## Work At WIVH Tower Site

"A new FCC requirement had to be met and the results of a special test recorded on WIVH's renewal form for its operating license," said WIVH manager, Burl Updyke. The test was to measure the RF activity at the tower site on Blue Mountain.

The testing was accomplished by a qualified RF engineer from Puerto Rico, Roger R. Fraites Negron. RF activity was well within range of requirements and the proper forms were sent along with the license renewal.

"This new requirement added yet another expense to the operation of WIVH, costing the station \$1300," said Burl. Each year expenses get greater here, he said, as he expressed thanks to the faithful monthly contributors making WIVH's broadcasting possible. He said he hoped that many more listeners would take to heart the fact that WIVH depends entirely on the support of listeners to meet its operating costs.
